ECEAP – new Performance Standards – on DEL website

- If child is not wearing sunscreen, they need to be protected from the sun by clothing or in shade
- Form filled out for using sunscreen
- Parents can also bring their own
- Under six months of age they need to be protected from the sun
- It is no longer considered a medication
